SCHEDULE OF PORT CHARGES

EFFECTIVE 1 JULY 2025.



Scheduled Rates represent the standard port charges compliant with statutory requirements as at publication.

Ship Charge:

The Ship Charge will be calculated on the Gross Registered Tonnage of the Vessel and charged to the Ship via the Agent. The Ship Charge will also include the use of Shore Tensioning Units at the discretion of the Harbour Master.

Berth Hire Charge:

The Berth Hire Charge is for vessels that remain alongside a port berth when not working cargo unless prevented by weather, surge or swell or otherwise at the discretion of Harbour Master. The Berth Hire charge shall be calculated on an hourly basis and charged to the Vessel via the Agent.

All Vessels:	\$313.85	\$285.32

Wharfage Charge:

The Wharfage Charge for all cargoes is calculated on the revenue tonnes loaded or unloaded and charged to the importer or exporter of the cargo. This charge is solely for use of the wharf and does not include charges for any loading or unloading service.*

**A 'revenue tonne' being a mass of 1,000 kilograms or a volume of 1 cubic metre or 1 kilolitre, whichever is the greater.*

Berth 4 & 5 Ship Loading Charges:

The Ship Loading Charge for bulk cargoes utilising the Bulk Handling Facility on Berth 4 or 5 is calculated in relation to the tonnes loaded and charged to the importer or exporter of the cargo.
